

## Non-Medical Drivers of Health Protocol

*This protocol applies to all Community First Health Plans, Inc. (Community First) health care physicians, health care professionals, facilities, and ancillary providers contracted to provide services to Community First Members, capture Non-Medical Drivers of Health (NMDOH), as defined below, and use ICD-10 diagnostic code(s), also called Z-codes, in the medical record and when submitting claims to Community First.*

### **What are NMDOH?**

NMDOH are non-clinical societal and environmental conditions, such as an unsafe living environment or lack of access to adequate food, health care, housing, transportation, or education. Other NMDOH include inadequate social support, behavioral stability support, and employment—conditions that prevent individuals from accessing the health care they need. Research shows that an individual's socioeconomic and psychosocial needs correlate with their health and wellness. Systematically identifying these non-clinical barriers to health care allows Providers and health plans to help patients overcome the barriers of the NMDOH they face by gaining a better understanding how NMDOH conditions influence the treatment process. Using the Z codes associated with these conditions will allow Providers and Community First to collect data and identify solutions that align with Members' needs.

### **Coding Guidance**

This NMDOH protocol applies to all Community First Members enrolled in Medicare Advantage (HMO), Medicaid, and Commercial products. Community First supports the use of the ICD-10 code classification system to collect, screen, and address Members' NMDOH where possible. Providers are strongly encouraged to routinely screen, document, and submit the appropriate ICD-10 code(s) when a Member is impacted by social barriers.

**Please use the ICD-10 codes listed on the following pages when submitting a claim for a Member affected by any non-medical category.** Although this list is not inclusive of all non-medical drivers, it is a step that Providers and Community First can take together toward improving the lives of our Members. Providers should stay current on the use of these NMDOH ICD-10 codes, as they may be updated intermittently.

### **Auditing Compliance**

The list of ICD-10 diagnostic codes that capture non-medical barriers has been expanded, approved, and incorporated into the ICD\_10 CM Official Guidelines for Coding and Reporting. Providers should train staff on these updates to the billing and coding process for complete and accurate medical diagnosis, recordkeeping, and claim submissions. Community First reserves the right to audit claim submissions retrospectively.
